1. CALL TO ORDER

Chairman Chris Blake called the meeting to order at 1:00 p.m. noting that a quorum was present.

MOTION by Chris Hart to approve the Consent Agenda. Seconded by John Bramall. Discussion: None. Vote was taken: All voted aye. Motion passed.

3. DECLARATION OF CONFLICTS OF INTEREST

a. John Bramall stated that Hurricane City filed an annexation plan in 1999 that included the Sand Mountain area. In the recent Hurricane City Council meeting the committee discussed encouraging the private land owners in that area to proceed with annexation.

6. <u>GENERAL BUSINESS</u>

a. Discussion of SUU/YCC Trail Restoration Project

Brian Raper, Partnership Director for the Intergovernmental Internship Cooperative (IIC), presented Exhibit 4-a-1. He discussed what the IIC does as well as their mission. He then discussed the work recently done on the Chuckwalla trail by SUU and the Youth Conservation Corps (YCC). Overall, the group established and repaired the trail, established water ways and improved drainage, cleaned and reinforced culverts, and designed and repaired trail drain dips. Brian discussed potential future projects and the committee thanked him for their efforts and is interested in having them back for more work in the future.

b. Update on land acquisition efforts – Bob/Dawna

Regarding section 6 acquisitions, the state Division of Wildlife Resources (DWR) has closed on the Virgin River Land Preservation Association parcel as well as the SITLA parcel.

Dawna reported the feasibility package for the Long Valley exchange is moving through Washington.

c. Update on permit renewal – Bob

Larry could not attend this meeting, and Bob did not have any updates on the permit renewal at this time.

d. Technical Committee Report

Cameron Rognan reported about a proposed road addition in the Diamond Valley area that a local developer brought to the TC. The committee decided to take a field trip to the site for further assessment prior to their July meeting.

In the previous HCAC meeting the committee sent the Quarry Trail proposal for route A back to the TC. Exhibit 6-e-1 is a map as well as a letter from St. George City showing a possible alternative route A, though the City Council would still have to approve this route. Cameron read the formal recommendation from the TC, as shown in Exhibit 6-e-2.

The final discussion from the TC was concerning the budget. The committee made a few changes and will have that to the HCAC for review in the next meeting.

e. Continuation of Quarry Trail proposal

Commissioner Gardner asked about the possibility of removing one trail to allow for the new Quarry Trail. After discussion regarding trail removal, alternate quarry sites, and the updated route A, the HCAC voted to send the issue back to the TC for further discussion and await answers from St. George City about whether or not proposed route A would be accepted.

MOTION by Chris Hart to continue the Quarry Trail awaiting additional information from the City and the TC. The TC will explore the following: an alternate quarry site, potential for mitigation by exchanging trails, and mitigation by changing the route. The HCP needs to know whether the City Council will accept the alternate route A, as shown in exhibit 6-e-1. <u>Seconded</u> by John Bramall. <u>Discussion</u>: None. <u>Vote was taken</u>: All voted aye. <u>Motion passed</u>.

f. HCP Administrator's report – Bob Sandberg

1. Cottonwood Road fuel reduction update

Bob updated the committee that there are still goats on Cottonwood Road working on reducing tumbleweed. The thistle is maturing so the goats have slowed down their eating, but they have done well thinning it and stomping down old tumbleweeds that have built up along the fence.

2. Update on mural project

Bob reported the mural painters were having trouble with the paint due to the heat so that project is on hold until the weather cools down.

3. Desert Garden/RCDR information panel

Bob reported he has been working with a biology class at Dixie State University that is creating a panel to put up at the Desert Garden giving information about the Reserve and desert tortoise.

4. Summer Intern

Bob mentioned the HCP hired a summer intern who has been working with Cameron on raven nest surveys, looking for raven predation issues. He has also been helping with trail work and signage.
